A Message from Bridgeway's Covid Task Force

It has been three years since the Covid pandemic began. It has been a difficult time for staff, persons served, and our families. Organizationally, we had to adapt quickly to the new reality. Using telehealth, depending on zoom meetings, wearing protective equipment, and getting vaccines and home test kits were only some of the many changes we had to make. We also had to deal with many emotional challenges, such as losing loved ones and the individuals we serve. Despite all these challenges, Bridgeway continued to provide services to people who depended on us. Credit must go to all Bridgeway staff for their dedication and commitment.

Although we still must deal with Covid, there has been significant progress. Nationally, cases, hospitalizations, and test positivity rates are flat. According to the New York Times, conditions are improving in much of the Northeast, where hospitalizations have decreased by 15% in the last two weeks. In October 2021, the daily average number of Covid positive cases was 30,000. By the end of December 2022, the average was about 2,500.

What does this mean for Bridgeway?

- Continue to wear masks when we visit persons served.
- Stay at home if feeling sick.
- Continue to self-test if you feel sick.
- Use your judgment about wearing a mask if you are at risk or have close contact with someone at risk.
- Stay current with your vaccinations.
- Maintain regular check-ups with your primary care provider.
- The medical QI Task Force will continue to meet weekly to monitor the situation and will let you know if there are any special measures we need to take.

Bridgeway Behavioral Health Services will soon have a *big* announcement to share about services in Hudson County, in the City of Hoboken - The Square Mile City, the birthplace of Frank Sinatra - and the soon-to-be home to Bridgeway's new **Center for Integrated Behavioral Health Care**.

The Center Director, Stephanie Simon, reports that this spring, renovations will be completed at 506 3rd Street, and Bridgeway's comprehensive Hudson County services will reside at one location. What this means is that **PACT** services (Program for Assertive Community Treatment) along with **Crisis Intervention Services**, currently located in Jersey City, will move in and become part of Hudson County's newest Bridgeway services at The Center.

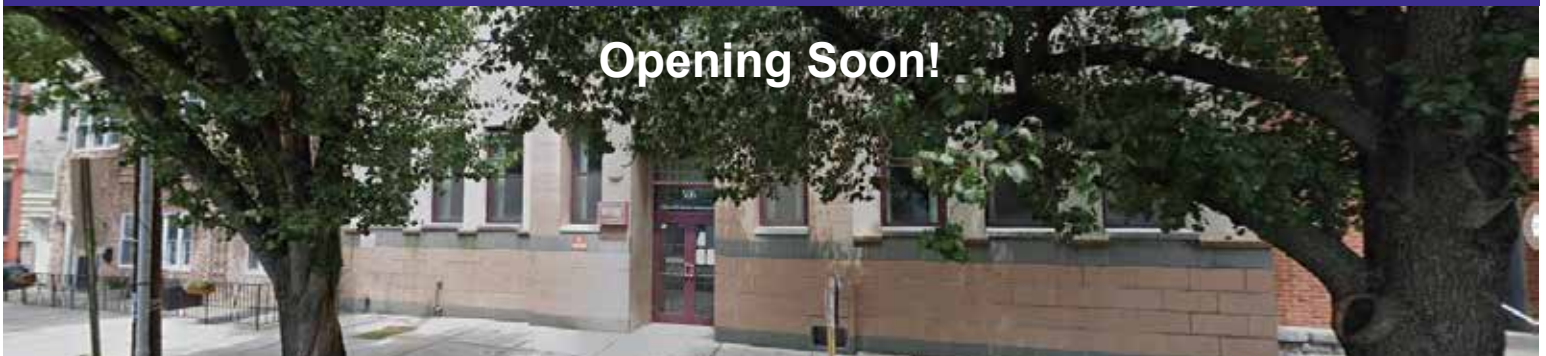
Once open, the **Center for Integrated Behavioral Health Care** in Hoboken will offer "one-stop" care for families:

- Screening for HIV and viral hepatitis A, B and C
- Services for Veterans
- PACT - Program of Assertive Community Treatment
- Collaboration with judicial officials and the court system
- Wellness, Recovery and Peer services
- Trauma-Informed Care
